COURT SAVVY led early, was engaged mid backstretch, dueled two-wide, drove clear upper stretch and widened under a hand ride. OPENING REMARK stalked the pace, closed three-wide late turn, chased into the stretch and finished gamely. UNBRIDLED PIPER stalked the pace from the rail, chased into the stretch, was gamely but was outfinished for place. LEOPARD CAT settled off the pace, was hustled late turn, angled out midstretch and rallied. GAZCADER settled off the pace, came two and three-wide through the turn, chased into the stretch and finished under a determined drive. MOZART MELODY settled off the pace, saved ground, angled out leaving the turn then evened out in the late stages. MIKE broke outward and settled off the pace, was hustled angling from three to five-wide on the turn, was determined but never reached contention. AUGUSTO B raced in midpack, hugged the rail but lacked a closing response. VINTAGE TIME forced the early pace from the rail, drew even mid backstretch, dueled, but tired upper stretch. COPPERSMITH raced in midpack, was hustled three and four-wide on the turn then flattened out midstretch.
