**Footnotes**

SIX SHOOTER stalked the pace early, shifted into the four path in the turn, made a bid down the lane, drove past the leaders and cleared the field in the final stages. POLE SETTER broke awkwardly from the gate, came in early on, tracked the pace, shifted into the three path in the turn and flattened out late in the stretch run. GO AWAY was cut off and clipped heels leaving the chute, raced back, shifted into the four path in the turn, rallied down the lane and was up for show in the finals stages. MY SIXTH SENSE set the pace early, shifted into the four path in the turn, remained clear down the lane but faltered late in the drive. COUNTER OFFER trailed the field early on, shifted into the four path in the turn with a belated gain in the stretch run. LE POND chased the pace early, shifted into the three path in the turn and faded late in the stretch drive. DABO was never a threat. PICO ENTRY was done early. CORAL LEGACY was through early. MOST MISCHIEF steadied early on. ALBANY FLEET showed little. AFTER A STEWARDS INQUIRY, POLE SETTER WAS

DISQUALIFIED AND PLACED THIRD FOR THE INFRACTION.
