Footnotes

BOX OF CHOCOLATES, prompted from the break outside foes to gain a forward placing racing into the first turn, stalked just off the leader into the backstretch while under light restraint, was urged to bid between foes midway through the far turn, couldn't gain even terms with the winner racing into upper stretch, but shifted out and continued with a sustained response to prevail in time under strong handling. BETTER CHARGE IT sped to the fore along the rail, dictated the pace on a narrow margin for a half, was joined by several rivals nearing the three furlong marker, kicked clear under pressure racing into upper stretch but faltered in late stages. ROCKNROLL ROCKET, urged to gain a position just off the first flight racing to the backstretch, continued outside a rival through the far turn, shifted in to split foes racing into the stretch and continued willingly to gain position to the end. KINETIC SWAGGER, forwardly placed between foes tracking just off the pacesetter in early stages, switched out after a half, then was urged to challenge three deep racing past the three furlong marker but flattened out midstretch. CAMPAIGN SPY, unhurried between foes tracking off the second flight, angled to the inside racing to the far turn, was caught in close quarters nearing upper stretch and had no final response. REplete, urged to gain a position while angling to the rail to gain terms with the second flight nearing the backstretch, tracked the leaders inside foes through the backstretch and steadily faded into the far turn. GOLD NOTE settled outside foes and failed to menace. GEORGIA DEPUTY exchanged bumps with WAVERUNNER at the start, was held up last early and proved no threat. ARGUTO settled along the inside early and offered no rally. WAVERUNNER broke inwards bumping a rival, was settled between foes and

proved no factor.
