M G WARRIOR off a step slow, raced well back while moving outside, advanced strongly into contention four wide into and through the far turn, showed the way into the stretch and drove clear. CHRIS AND DAVE lacked speed, steered out to be four wide when moving forward late in the final turn, finished up willingly to be in time for the place. TIMELINE back early off the pace, followed the winner in the four path toward the front in the second turn, flattened out in failing to keep up with that rival, lost the place late. GORDY FLORIDA dueled up front while racing closest to the inside, helped set some lively fractions, weakened in the drive. PETROV settled in the second flight just off the inside, came up empty for the drive. EXTIRPATOR closest to the dueling leaders off the inside, had little left for the drive. MISTER BANJOMAN vied up front off the inside, steadied when appearing to begin tiring far turn, fell back and then continued to fade. SHIVERMETIMBERS was finished early, stopped far turn, jogged in, walked off.
