ZOOM UP moved up on the outside after the start then stalked the pace, went three wide on the turn, was bumped four wide at the quarter-pole, chased outside into the final sixteenth and got up late to gamely prevail. THAT'S A GIANT NO bumped hard with a rival at the start, was well placed just off the pace, rounded the turn in the two path, shifted three wide and bumped with ZOOM UP at the quarter-pole, made an outside bid before the furlong marker, gained the lead into the final sixteenth but was denied. ANOUSH pressed the pace on the outside of the leader, vied in the two path on the turn, came under a drive in upper stretch, led past the eighth-pole, fought on well in the final furlong but missed while able to get the show. SISTER LUCK broke in at the start, set the pace under pressure to her outside, vied along the rail on the turn, was asked at the quarter-pole, battled under a drive into the final sixteenth and was outfinished. PAULINE'S PEARL bumped hard with a foe at the start and was off a step slow, raced well back in the field, saved ground on the turn, turned into the stretch in the two path, hesitated then altered in from behind horses around the three-sixteenths and improved position. SUKI broke in and was off slow, spotted the front a few lengths then was hustled, raced on the outside under urging, dropped back four wide on the turn and failed to rally. DELLA FROST broke in at the start, steadied while in tight early, saved ground on the turn and failed to threaten. SYMPTOM settled on the outside, was urged four wide on the turn, came five wide into the stretch and was no factor. MY TOMMY LEE settled off the pace, was roused leaving the backstretch, went three wide on the turn and failed to respond. REMINISCENT was fractious behind the gate while reluctant to load, raced towards the rear under urging, dropped back leaving the backstretch, went three wide on the turn and also failed to respond. PER STEWARDS MEDICATION RULING 24165 ZOOM UP DISQUALIFIED AND PLACED LAST.
