HE'SMYHONEYBADGER pressed the pace two wide, bid for the lead at the five sixteenths pole before forging an advantage entering the lane with KING'S OVATION menacing outside, shifted from left handed urging into that foe's path approaching the final sixteenth, grazed that foe's shoulder while causing that one to shy, then drew clear to the wire. KING'S OVATION tracked three wide, came under a drive into the far turn, sustained chasing position entering the lane as HE'SMYHONEYBADGER took over, ranged up to that foe passing the furlong pole to attempt a bid, but shied when brushed by that rival at the sixteenth marker, lost his momentum and failed to match strides thereafter. RAM tracked along the inside, secured pocket-stalking position into the far turn, shifted two wide entering the lane, but only managed to chase the leaders home while passing a tiring foe for show. WARRIOR IN CHIEF set the pace while staying a bit off of the inner railing, met HE'SMYHONEYBADGER's bid around the far turn before being headed by that foe entering the lane, then yielded through the final furlong. SITTIIN ON GO lagged behind and was outrun. THE RIDER OF KING'S OVATION CLAIMED FOUL AGAINST THE RIDER OF HE'SMYHONEYBADGER FOR INTERFERENCE IN DEEP STRETCH, BUT IT WAS DISSALLOWED BY THE STEWARDS.
