Footnotes

SWOT ANALYSIS set the pace inside of a pressing CREOLE CHARLIE, drew off passing the quarter pole, widened under mild hand urging through midstretch, and required right rein correction to keep from lugging in through the final sixteenth. RELEASE THE BEAST trailed, swung to the six path entering the lane, and rallied outside of foes to reach place at the sixteenth pole. CREOLE CHARLIE pressed the leader from the outside around the turn, but failed to keep pace at the quarter pole, and lost place to an outer rival a sixteenth from home. PICKENS tracked along the inside, came into the lane in the two path, but lacked a bid. ZION tracked the pace three wide, shifted to the four path entering the lane, but tired. WIDDLE ZEE tracked to wide and from between horses, came into the lane in the three path, and faded. NO HEAD ON REPLAY SHOWN
