VERIFYING pressed the pace in the three path, bid at the quarter pole, dueled through the final yards and prevailed under a strong hand ride. RAISE CAIN stalked the pace inside, bid five wide at the quarter pole, came in slightly late, dueled and was outfinished. CAGLIOSTRO stalked the pace inside, bid in early stretch, had no room and bumped a foe when a hole closed, then found room too late. TRANSECT was clear early, vied inside, was bumped at the three-sixteenths pole, then yielded. GEORGIE W stalked the pace in the five path, bid at the three-eighths pole, then gave way the stretch. ONTHESTAGE and HAYES STRIKE raced well back and failed to menace.
