FILLIES, THREE YEARS OLD. Free nomination by Sunday, December 24. \$1,250 to enter. \$125,000 Guaranteed. A \$100 supplemental nomination fee may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. \*(FTBOA offers up to \$20,000 to the owners of Registered Florida-breds, divided \$10,000 to the winner, \$6,000 to second, \$4,000 to third).Weight: 122 lbs. Non-winners of a graded stakes on the turf allowed 2 lbs.; Graded stakes placed or non-winners of a race other than maiden, claiming, starter or state-bred allowance, 4 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the start of the race. Preference will be given to stakes winners, stakes placed then by highest career earnings. Trophy to the winning owner. (If deemed inadvisable to run this race over the turf course, it will be run on the Tapeta Course at One Mile and Seventy Yards) (Rail at 45 feet).

**Footnotes**

OZARA (IRE) stalked in the two path, waited patiently for an opening around the far turn, was coaxed while tipping to the rail at the top of the lane, took the lead passing the eighth pole, and drew clear. LIFE'S AN AUDIBLE raced wellback in the three path, was coaxed in the four path midway around the far turn, angled out to the center passing the eighth pole, and rallied for place. WASKESIU had an awkward start, chased in the five path, floated out to the six path under a drive into the stretch, and kept on for show. MADAME MISCHIEF rated in the two path, was roused along the inside midway around the far turn, was in tight between foes in the two path passing the eighth pole, and mildly stayed on. BUTTERCREAM BABE tracked in the four path, was ridden around the far turn, floated out to the five path entering the stretch, but flattened late. DANCING N DIXIE bumped with an inner foe at the start, trailed in the two path, was roused from the rail passing the quarter, but got stymied passing the eighth pole, and made no impact. TIME TO DAZZLE got rank going into the

first turn, raced off the pace in the four path down the backside, floated out to the six path early into the far turn, and did not threaten. INDEPENDENCEAVENUE prompted the pace in the four path, was cued to bid turning into the stretch, but weakened. OMAHA GIRL bumped with an outer foe at the start, raced in midpack in the three path, but backed up between foes turning into the lane. SAN PANTALEO set the pace in two path, was coaxed passing the quarter, tipped out to the three path at the top of the stretch, but gaweway between foes in the final furlong.
