ABRUMAR popped the gate door open during the loading process, showed the way around the first turn to set the pace along the inside down the backstretch, waited confidently rounding the far turn, was roused from the three path at the top of the stretch, drifted out slightly while digging in, and gamely held off an outer pair. CUGINO tracked in the three path, was cued while three wide early into the far turn, bid from the five path turning into the lane, got herded outward, but ran on to be up for place. SILENT HEART laid up close in the two path, bid in hand rounding the far turn, was roused from the four path into the stretch, but drifted out, and hung between foes for show. TRIPLE ESPRESSO raced off the pace in the three path, was cued passing the quarter, floated out to the six path at the top of the stretch, and finished evenly. ROYAL MAJESTY (GB) trailed along the inside down the backstretch, was coaxed passing the quarter, fanned out to the eight path at the top of the lane, and stayed on, but made no impact. RAPTURE BAY stalked inside but flattened from the two path in the stretch. TOCAYO laid in midpack in the two path turning into the backstretch, but lost ground between foes rounding the far turn, and failed to bid in the four path down the lane. OKIRO was in tight and had to steady midway around the first turn, raced wellback in the two path but did not threaten from the five path in the stretch. FREEDOM PRINCIPLE rated inside but was no menace.
