Footnotes

ADMISSIBLE laid off the pace in the three path, waited in the two path rounding the turn, bumped an outer foe to force her way out to the seven path in upper stretch, and rallied to get up on the wire. MY LADY JAMES prompted the pace in the four path, bid in the three path passing the quarter, took the lead while being roused from the five path into the stretch, was briefly clear around the sixteenth, but got nailed by an outer foe at the wire to place. CYMBAL COURT got bumped twice by an outer foe at the start, tracked inside but had to steady going into the turn, split foes in the two path passing the quarter, floated out to the six path entering the stretch, and kept on while tipping inwards in the final sixteenth for show. JORDI'S DREAM bumped an inner foe twice at the start, stalked in the four path but had to steady early, was ridden around the turn, but got bumped out to the eight path in upper stretch, and finished evenly. KICK A RHYME (IRE) trailed in the four path, was coaxed in the five path midway around the turn, but made no impact. SILVRETTA (GB) chased in the five path, but got herded out to the ten path in upper stretch, and did not factor. BOSTON ROSE (IRE) rated in the four path but never threatened. FROZEN SOLID laid up close in the three path but had to steady going into the turn, and failed to bid. CAVU set the pace in the two path but gaveway in the final furlong.
