SEATTLE ROAD saved ground off of the pace, sustained gradual rail progress through the final furlong and got up at the wire. CROMWELL broke outwardly and was off a step slow, lacked speed in the four path, retreated entering the backstretch to trail the field, swung out to the six path picking up stride entering the lane, rallied in the final furlong to offer a late bid between horses but missed. MORLOCK set a clear pace around both turns, held sway through midstretch, but drifted out subtly while tiring in the final sixteenth, was caught between horses and saved show at the wire. PRETTY CAPABLE leaned inwardly and was off a step slow, tracked along the inside, chased around the far turn, shifted out to the five path entering the lane, ran on to close in on the tiring leader in the final sixteenth, but checked behind that one late and missed show. YINZER tracked three wide, ranged up into the far turn, chased the clear leader through upper stretch, but veered outwardly entering the final sixteenth, straightened course and kept on late, but was outkicked by inner rivals. STRATEGIC FORCE broke a beat slow, saved ground well back and improved. NATIVE RUNNER broke inwardly and bumped a rival at the start, lacked speed two wide, spun for home in the five path and between horses and failed to factor. LIMITED EDITION pursued from midpack two wide and

between horses, then three wide around the far turn, moved out to the five path into the lane and failed to factor. REDACTED stalked two wide, then between horses into the far turn and faded. FEVER NIGHT was bumped by an outer rival at the start, laid off of the pace in the three path, crept closer in the four path down the backstretch but faded turning for home. THE RIDER OFFPRETTY CAPABLE CLAIMED FOUL AGAINST MORLOCK ALLEGING INTERFERENCE IN DEEP STRETCH, BUT THE OBJECTION WAS DISALLOWED BY THE STEWARDS.
