FOR THREE YEAR OLDS . This is a Non Lasix Race. ( Lasix not permitted within 48 hours of post time.) No Nomination Fee. \$250 to pass the entry box. \$500 additional to start. Purse to be divided: \$60,000 to the Winner; \$20,000 to Second; \$10,000 to Third; \$5,000 to Fourth; \$2,500 to Fifth; \$1,500 to Sixth, \$500 to Seventh and Eighth, and \$250 each to Ninth through Twelfth. WEIGHT: 124 lbs. Non-Winners of \$60,000 in 2026 allowed 2 lbs.; \$45,000 in 2026, 4 lbs.; \$30,000 in 2026, 6 lbs. (Maiden and Claiming Races not considered in estimating allowances). This Race is Limited to Twelve (12) Starters with Two (2) Also Eligibles. In the event more than Twelve (12) Entries pass the Entry Box, preference to start will be given to those horses with the highest lifetime earnings according to Equibase. Supplemental nominations may be made at the time of entry by payment of \$1,500 that covers both entry and starting fees. SQUAD GOALS unhurried to race at the back of the field down the backstretch, closed the gap on the turn while saving ground, cut the corner turning for home and rallied strongly up the inside to be clear late. DOUBTING THOMAS reserved off the pace to race with the winner at the rear, likewise closed ground on the turn from three wide, lacked the burst the victor had in upper stretch and followed him along the inside with a late gain for the place. LIVE STREAM rated in mid-pack down the backside, gained on the turn to be prominent turning for home. loomed in mid-stretch from between rivals and was outfinished in the final eighth. GRUNGE stalked the pace for half to be well placed at the head of the stretch, rallied to engage the leaders midway down the lane and was outkicked in late going. SMALL TOWN tracked the leaders to the quarter pole, rallied as part of the cavalry charge in upper stretch to be prominent at the eighth pole and hung late. CARNIVAL ROCK showed early speed to be in the second flight, dropped back losing position on the turn and

kept-on in the lane passing tiring rivals. KING OF SHEBA pressed the pace down the backside, continued to duel through the turn taking the lead at the quarter pole and gave way in the stretch. MR. HOOLIGAN raced wide down the backstretch, was caught wide into the far turn to be in the seven path and failed to menace. ZUN DAY sped to the lead dueing through rapid fractions for a half mile and faltered. THE RIDER OF MR. HOOLIGAN CLAIMS FOUL FOR INTERFERENCE AT THE THREE-EIGHTHS POLE BY SMALL TOWN, UPON REVIEW THE STEWARDS MADE NO CHANGE.
