ARMY'S MARAUDER pressed two wide, maintained pressure between horses after coming under urging with three furlongs to go, was kept at bay through midstretch yet determinedly sustained her bid to forge even terms in the final sixteenth and pushed past late. KAYKAY set the pace along the inside, held sway from an outer presser into the final furlong, but got collared by that persistent for in the final sixteenth and was bested late. MAGIC WOMAN laid off of the pace near the inside, altered course inwardly in midstretch and ran on to gain show. SASSY ONE stalked outside of the eventual top pair into the turn, maintained striking position turning for home, but proved no match for them in upper stretch then yielded show late. LOVE DIVINE leaned inwardly leaving the gate, trailed along the inside, improved off of the rail into upper stretch, progressed while shifting out to the six path in midstretch then forged fifth at the ire. R KENDL stalked along the inside but proved no match while chasing in upper stretch and gave way. DRAW floated inwardly at the start, lacked speed along the inside, got floated to the four path around the turn, swung out to the seven to eight path in midstretch and failed to menace. EVER AFTER laid off of the pace in the two path, shifted to the six path in upper stretch but hung on her left lead and lugged inwardly. DETERMINED ACE brushed with an inner foe at the start, lacked speed in the three to two path then failed to factor. PERMUTATION brushed an outer foe at the start, tracked from the three path,

chased in the four to five path in upper stretch, lacked a bid and tired. LUNAR LOOP chased from midpack in the four path then gave way in the four to five path around the turn. COCOA BEAN lacked speed in the five path and got outrun.
