TAXABLE GOODS disputed the pace in the two path then drifted out in the final furlong and prevailed. TIZCREETLY, well placed just off the early pace, was steadied on the heels of the drifting winner in the final furlong and continued willingly. BENEVOLENT PRINCE was forwardly placed but lacked the needed response in the stretch. CIBOLA got out at the start then failed to threaten. LINDA'S NEKIA lacked a rally. BEL GIORNO failed to threaten. CULLASAJA KING saved ground disputing the pace to the far turn then had little left. MR. GIO was shuffled back at the start. A claim of foul by the rider of TIZCREETLY against the winner for interference in the stretch was not allowed following a stewards inquiry.
